Washington Update

I spent most of my week on Capitol Hill advocating for programs and initiatives that support the teaching profession. I can tell you, it was a madhouse up there – the frenzy that occurs right before a recess! (Join me on twitter and come along to the Hill with me! @janewestdc)

Budget and Appropriations: Over Before it Starts?

The Senate and the House wound up this legislative session yesterday set to take next week off. Both bodies will reconvene May 9. The Senate was all set to forge ahead this week passing its first of 12 appropriations bills for FY 2017. The bill chosen was considered an “easy to pass” one – the Energy/Water bill. But alas the bill is stalled because of an amendment offered by Sen. Cotton (R-AR) that Democrats and the White House believe would undermine the Iran nuclear agreement. If the amendment were adopted, the White House has indicated the bill would be vetoed. This has caused the Senate to stall, unable to move to final passage after trying twice. They will try again the week of May 9; however, this does not bode well for the 11 appropriations bills that need to follow. This amendment may be one of multiple “poison pill” policy riders which may emerge putting a halt to additional bills. There was no movement in the House on appropriations bills.

We may see Committee markups on the Labor/HHS Education Appropriations bills in June in both the House and the Senate. But there is little hope that those bills will make it to passage on the House or Senate floor before September 30, leaving the likelihood of a “CR” or “continuing resolution” to be high. The CR represents an extension of existing funding levels which would likely carry through until after the November elections. For those of you who are eager to learn more about the federal Education budget and key concepts related to federal education spending, you are in luck! ESSA: The Department of Education Seeks Input; Draft Assessment Regulations Released

The Department of Education has put out a call for recommendations about which parts of the new law would benefit from their guidance. Guidance, unlike regulations, is not binding. It is intended to help the public understand the law and provide examples of best practices. Among the areas the Department of Education is interested in are: ways to expand early learning; strategies to recruit, develop and retain teachers and leaders; diversity and equity; building and using evidence-based practices; professional development and educator evaluation; teacher leadership; student support services; serving students in foster care, homeless children and youth and English Learners.

May 25, 2016 is the deadline for comments. The Department requests that comments be submitted by email to: ESSA.guidance@ed.gov with the following directions:

- Note topic area in subject line
- Include in the email your name and, if applicable, your organization

This week the Department of Education also released the final language on assessments from the recently concluded ESSA negotiated rulemaking session. The panel came to consensus on this language (though not on the “supplement not supplant” provision). This language, along with a proposal from the Department of Education on “supplement not supplant,” will be issued later this year as an official Notice of Proposed Rulemaking, inviting public comment.

Washington Update

Among other items, the assessment agreement addresses requirements for school districts that want to utilize a “locally selected, nationally recognized” test instead of their state exam. Options include ACT, SAT, PARCC, Smarter Balanced test. It also address requirements related to the assessment of students with the most significant cognitive disabilities using alternate assessments tied to alternate achievement standards – the “1% requirement.”

Comments on Two Key Regulatory Proposals Due May 2 and May 16.

Two sets of proposed regulations (NPRM's) are out for public comment and due dates are fast approaching. By May 2, you can comment on the Department's additional proposal on teacher preparation distance education programs. This notice opens the previous proposed teacher preparation regulations for additional comments on how they would apply to distance education programs, particularly those that operate in multiple states.

By May 16, you can comment on the Department's proposal to address disproportionality in special education. IDEA requires states to identify districts with “significant disproportionality” in special education, e.g. when districts identify, place outside of general education classrooms or discipline students from any racial or ethnic group at a markedly higher rate than their peers. The proposal requires states to implement a standard approach to determining disproportionality and, as the law requires, use 15% of IDEA funds to remedy the disproportionality.

Time to Embrace your Duty (TED)

Now more than ever, TED needs YOU, particularly if you have not yet served YOUR organization! Opportunities abound for getting involved. Below I highlight the activities most closely aligned with my responsibilities as Past President, but there are a myriad of other choices!

TED Awards Committee

We need volunteers to serve on the TED Awards Committee. The constitution states: "The Awards Committee shall recommend and implement policies and procedures pertaining to awards bestowed by the Division." In particular, this committee solicits nominations and bestows the TED Distinguished Service Award and the TED Dissertation Award for Doctoral Level Research. This committee also responds to input from members regarding changes in awards or award procedures.

TED Elections and Constitution Committee

Volunteers for the TED Elections and Constitution Committee would be welcomed! Again, the TED constitution states, "The Elections and Constitution Committee shall have responsibilities pertaining to the solicitation of nominations and management of elections within the Division and for periodically reviewing and recommending revisions to the Division's constitution and bylaws." Any takers for helping with these duties?

Another option for getting involved is to run for an office. All terms of office run from January 1 through December 31. All elected officers become a member of the TED Executive Committee and the TED Executive Board. Each year the serving officers must commit to attending the TED Executive Committee and TED Executive Board meetings held at the annual conferences of CEC and TED. Work is also required in between these conferences.

The following elected positions will become open as of January 1, 2017:

Vice-President is a four-year commitment because it is part of the presidential line. The first year is served as Vice-President followed by President Elect, President, and Past President. Those serving in the presidential line commit to attend a meeting on-site in January, as well as video conferencing monthly. Each presidential position carries unique responsibilities which can be read in the TED constitution at <http://tedcec.org/docs/default-source/default-document-library/constitution-1113.pdf>

Secretary is a two-year commitment and the secretary can run for a maximum of two consecutive terms. The secretary takes minutes at all TED Executive Committee, Executive Board, and Business meetings.

TED Representative to the Representative Assembly of CEC is a two-year commitment. TED has two representatives at any given time. Duties include communicating issues and concerns from TED to the CEC Representative Assembly and to inform TED about the Assembly's issues and advice which are forwarded to the CEC Board of Directors.

Member-at-Large: Political Action, is a three-year commitment. This member-at-large advances TED's political position by chairing the Governmental Relations Committee, serving as the TED representative to the Children and Youth Action Network (CAN), working with the TED Legislative Liaison, and heading TED's PALs and GALs program.

2016 TED DISSERTATION AWARD FOR DOCTORAL LEVEL RESEARCH

Dr. Mary Anne Prater, TED Past President and Awards Chairperson, is soliciting nominations for the 2016 TED Dissertation Award for Doctoral Level Research.

The purpose of the award is to recognize doctoral students who have focused their research on the preparation of pre-service and in-service educators serving students with disabilities or who have conducted related research having clear implications for the preparation of educators serving students with disabilities.

Nominated individuals must meet the following criteria:

- Applicant must have received the doctoral degree within the 18 month period prior to the September 15, 2016 deadline.
- Dissertation research must address the preparation of pre-service and/or in-service educators serving students with disabilities or have clear implications for the preparation of educators serving students with disabilities.

Nomination Materials

Nominees must submit the following items in an electronic application packet:

- Title page that includes the following information: Dissertation title; Author's name, current address, phone number and e-mail address; Date of dissertation; Name of degree-granting institution; Name of dissertation committee chair;
- Documentation of approval or awarding of the degree;
- The dissertation abstract (not to exceed 150 words); and
- A 5-10 page manuscript, outlining and summarizing the research using APA guidelines. Manuscripts submitted for this competition may have already been submitted/accepted for publication. If submitted or accepted, appropriate referencing must be provided.

Deadline for Receipt of Materials

The deadline for receipt of nomination materials is September 15, 2016.

Spark Award

Accepting Nominations for TED's inaugural **Jane West Spark Award**

The Executive Committee of TED is please to announce nominations are being accepted for TED's Jane West Spark Award. The award recognizes a doctoral student who has demonstrated emerging leadership in policy advocacy for the profession of special education teacher education. Nominees must meet the following criteria:

- a. They must be involved in advocating for special education teacher preparation (e.g., government relations, letter writing, visits to Congressional Members), and be committed to continuing this work in the future;
- b. They must submit a fully completed application; and
- c. They must be student members of CEC and TED.

The application package will include, (a) a letter of past and future commitment to policy advocacy, (b) three letters of nomination described below, and (c) a current curriculum vita. The letter of past and future commitment should address (a) professional service goals, both past and future, (b) evidence of impact and/or influence on peers and others, and (c) a discussion about potentially pressing issues for the profession, along with suggestions about how the profession might address these issues.

Three letters of nomination should be submitted, including a letter from a peer, an advisor, and another individual who is knowledgeable about the nominee's experiences with policy advocacy. Letters should document leadership potential and influence related to advancing policies in the field of special education teacher preparation. Consideration will be given to:

- a. Commitment to continued policy advocacy for teacher education in special education;
- b. History of commitment to special education advocacy; and
- c. Actions taken to inspire others to commit to advocacy

Kaleidoscope

CEC St. Louis

Over 40 doctoral students presented posters on their research at the Kaleidoscope program at CEC in St. Louis. We would like to thank all of the faculty members who volunteered as reviewers during the session and to extend congratulations to the participants selected as winners in each category. The winning presentations included Jared Morris' Task Sequencing of Math Assignments for Students with Disabilities: A Literature Review and Samantha Mrstik's An International Perspective on Special Education in the literature review category; Matt Taylor and Claire Donehower's Using Simulation to Improve Interprofessional Communication Skills in the quantitative research category; Kari Muentz's Content Knowledge Pedagogy to Inclusive Pedagogy: Preparing Social Studies Preservice Teachers for the Inclusive Paradigm Shift in the qualitative research category; Taylor Bousfield's An Examination of Teacher Pedagogy with Students with Autism Spectrum Disorder Utilizing an Inclusive Classroom in TeachLive, and Gliset Colon's Effects of PALS on Reading Skills of ELLs With and Without Disabilities in the single case design category.

Diversity Strand at TED 2016

We would like to announce a Diversity Strand within the TED 2016 conference in Lexington, KY this fall. The focus of the Diversity Strand this year is Developing Equity-Focused Advocates. This strand will include a block of featured sessions in various formats (i.e., paper, round table, multi-presentation, poster, etc.) which will address topics centered on diversity, equity, advocacy, and inclusion. This strand will culminate with a three-hour Diversity Symposium that will feature presenters who will provide training and activities that support teacher educators in teaching students from diverse populations (e.g., race/ethnicity, socio-economic status, LGBTQIA).

At this time, we would like to announce a call for TED 2016 conference proposals, specifically targeted for the Diversity Strand. Proposals should feature research, practical applications, or other related examples of inquiry related to issues around Developing Equity-Focused Advocates. Content reflected in the proposals should be relevant to teacher educators, in-service practitioners, and/or pre-service teachers.

When submitting proposals, authors should indicate the session format(s) preferred (i.e. paper, round table, multi-presentation, poster, etc.) for their presentations. In order to make this impact, teacher educators must be culturally competent and inter-culturally sensitive to the needs of those who will follow in their stead at the higher education and school district levels. This monograph begins to fill the gap in the literature and practice focused on equipping higher education faculty and their doctoral students with the knowledge, skills, and dispositions to effectively prepare practitioners to work with diverse learners with exceptional needs, their families, and in diverse settings.

Small Special Education Programs Caucus (SSEPC) Nasim Dil Award Nominations

The Nasim Dil Award for Outstanding Service to Teacher Education is an annual award given to an individual who has demonstrated exemplary service to the development and advancement of quality teacher education in special education.

Criteria: The criteria for the selection of the recipient of the Small Special Education Programs Caucus (SSEPC) Nasim Dil Award for Outstanding Service to Teacher Education include demonstrated commitment to personnel preparation in small special education programs through two or more of the following areas:

- Service in leadership roles to advance teacher education opportunities in small special education programs (e.g., holding a leadership position(s) in teacher education organizations, recipients of honors and awards - either at home IHE or on the national level);
- Active promotion of quality teacher education in small special education programs (e.g., writing articles for the SSEPC Monograph, being involved in state initiatives involving teacher education, developing innovative teacher education curricula and teaching practices, etc.);
- Active participation in activities promoting opportunities for faculty from small special education programs to have a voice in the field of special education teacher education (e.g., encouraging and leading SSEPC members' involvement in political and educational activities that relate to teacher education, being involved in state-level decision making involving teacher education);
- Active participation in activities promoting collaboration (in terms of research and professional development) among members of SSEPC (e.g., initiating, developing, and coordinating activities that involve several SSEPC members: conference presentations, research projects, co-authoring, SSEPC-sponsored events, etc.); and/or
- **Active participation in SSEPC service in leadership roles to advance teacher education.**

Nominees must meet the following criteria:

- a. Must be a member of TED and SSEPC.
- b. Nominees may be nominated or self-nominate.
- c. Previous award winners will not be eligible again within a 10 year time period.

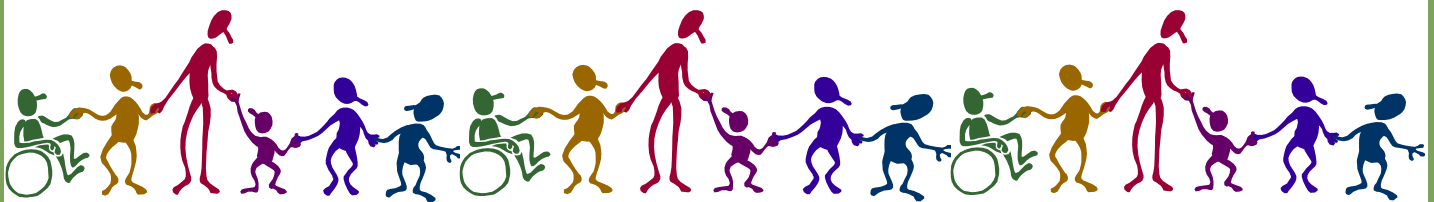
Electronic Nomination Materials should include the following:
